Objective and Investment Policy

The objective of this Sub-Fund is to track the performance of the S&P World Consumer Staples Screened Index (the "Index"). The Sub-Fund aims to achieve a level of tracking error of the Sub-Fund and its index that will not normally exceed 1%.

Description of the Index

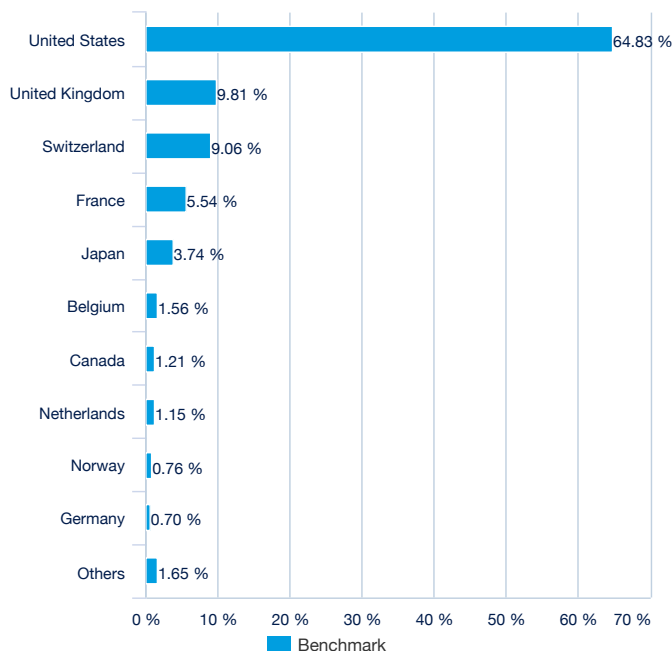

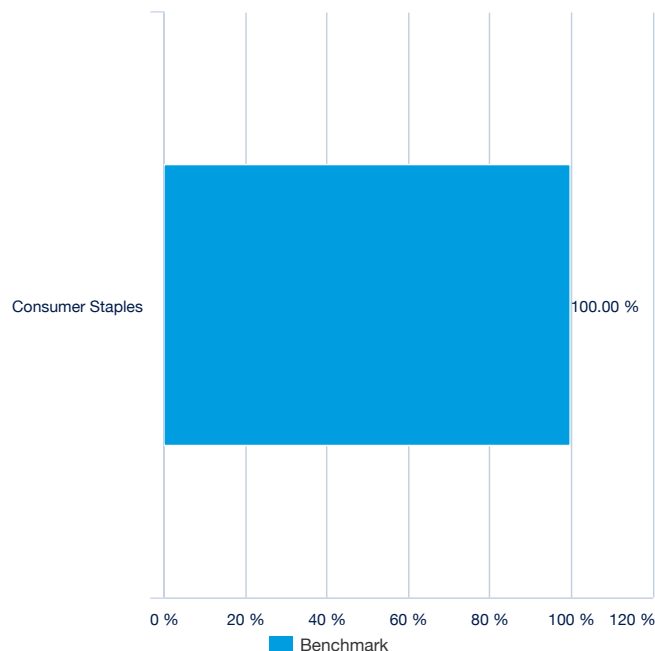
