On 13 March 2025, the Management Company informed you via a notice to unitholders (the "**First Notice to Unitholders**") of the amendment to the Fund's Prospectus in order to reflect the guidelines of the European Markets Authority ("**ESMA**") on funds' names using environmental, social and governance ("**ESG**") or sustainability-related terms (the "**Guidelines**¹").

This notice hereby informs you that the Management Company has decided to amend these changes announced in the First Notice to Unitholders and replace them with the changes set out in the table below:
