Objective and Investment Policy

The objective of this Sub-Fund is to track the performance of STOXX Europe 600 Insurance Index (the "Index"), and to minimize the tracking error between the net asset value of the Sub-Fund and the performance of the Index. The anticipated level of the tracking error, under normal market conditions is indicated in the prospectus of the Sub-Fund.

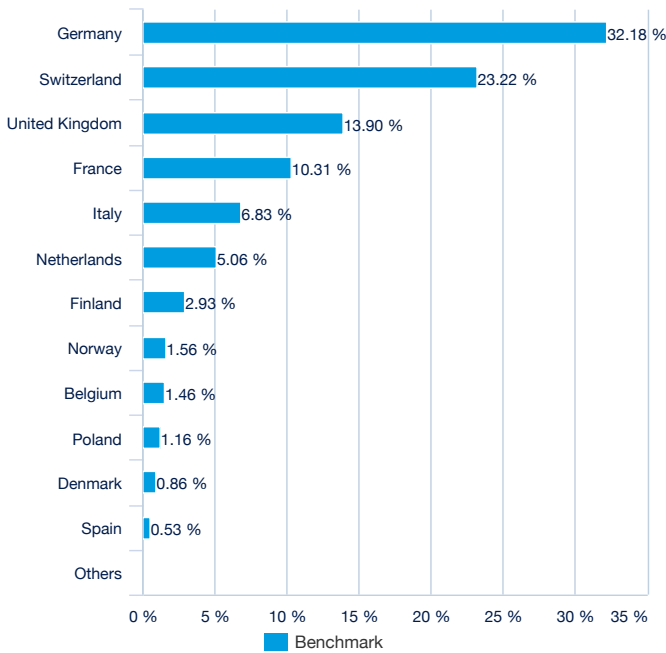

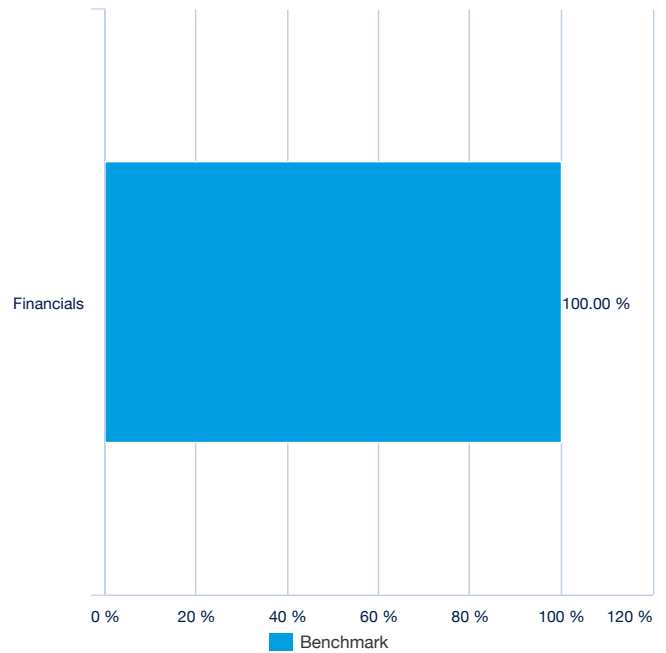
