## What is this product?

**Type:** Shares of a Sub-Fund of Amundi Index Solutions, an Undertaking for Collective Investments in Transferable Securities (UCITS), established as a SICAV.

**Term:** The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

**Objectives:** The Sub-Fund is an index-tracking UCITS passively managed.

The investment objective of Fund is to reflect the performance of the FTSE Eurozone Italy Government 1-3Y (Mid Price) Index (the "Index") denominated in Euro (EUR) in order to offer an exposure to the performance of the Italian government bonds having a maturity between 1 and 3 years while minimizing the volatility of the difference between the return of the Fund and the return of the Index (the "Tracking Error").

The anticipated level of the tracking error, under normal market conditions, is indicated in the prospectus of the Sub-Fund.

The Index is a total return index (i.e. all coupons from the Benchmark Index components are reinvested in the Benchmark Index).

The Sub-Fund seeks to achieve its objective via a direct replication, by investing primarily in the securities comprising the Index.

To optimize the Index replication, the Sub-Fund may use a sampling replication strategy, and may also engaged in securities lending transactions.

**Intended Retail Investor:** This product is intended for investors, with a basic knowledge of and no or limited experience of investing in funds seeking to increase the value of their investment over the recommended holding period with the ability to bear losses up to the amount invested.

**Redemption and Dealing:** The Sub-Fund's shares are listed and traded on one or more stock exchanges. In normal circumstances, you may deal in shares during the trading hours of the stock exchanges. Only authorised participants (e.g., selected financial institutions) may deal in shares directly with the Sub-Fund on the primary market. ## What are the risks and what could I get in return?

### RISK INDICATOR



The risk indicator assumes you keep the product for 3 years.
